Residents Neighbourhood Development Plan report 13

Over the last two months we have analysed responses from residents and also from our 'statutory consultees'; mainly groups such as Highways England, National grid and Historic England. Almost all of the responses were supportive and positive. Historic England, however, said we could do more to draw attention to the many assets in the Parish that are of historic interest. This work is almost complete. In addition, Northumberland County Council have carried out a screening assessment of the area which has shown that a full environmental impact assessment is required. This is primarily because we are likely to need a small number of houses in the lifetime of the NDP and we need to assess the impact this is likely to have on the number of people wanting to access the Area of Outstanding Natural Beauty. Any increase in numbers must be monitored carefully and a financial levy is often made on new houses where people are living close to the AONB. This assessment is now underway. Steppey Lane Bridge

We are very pleased that Northumberland County Council has allocated funds to carry out an initial study to decide on the best way to improve accessibility to the bridge. Once that work has been completed we will have a better view of costs and the extent of the work needed.

Northumberland Estates Outline Planning

We had anticipated being able to tell you about the outcome of the applications to build over 100 houses in the Parish. However, we understand that Northumberland Estates are submitting more information in support of their applications and in response to the objections that have been raised. There is still time to send in a response if you have yet to do so and, if you have already submitted your response, you are allowed to send in



additional information if you wish to make further comments.

New Parish Councillors and Annual Parish Meeting

We are delighted that Bob Whittaker, who lives on South View, joined the Parish Council March. Since then, Sir John Hall has resigned as he is very heavily involved in work relating to The North of Tyne initiative. This

Our Annual Parish Meeting takes place at 7.30pm on Tuesday 28th May, 2019. Residents are warmly invited to attend.

Aln Valley Railway

Last year the Aln Valley Railway received an EU grant for the construction of a halt at Greenrigg, just over half way along the line to Alnmouth station. The halt will comprise a platform, run round loop and a siding. Passengers will be able to alight from the train and



visit the AVR café and toilets which will be located in a former British Rail carriage placed in the siding. They will be able to walk along various permissive pathways towards Lesbury or Alnmouth or along the Greenway beside the rail track that is being constructed by Northumberland County Council, also with the aid of an EU grant. When complete, the halt will provide a destination for passengers travelling from Lionheart station as well

as walkers, horse riders and cyclists – known as a Greenway. The establishment of a halt at Greenrigg will open up the countryside to many people who are unaware of this beautiful, but hidden, part of Northumberland.

Elections

The Village Hall will be used as a Polling Station for the election of a Mayor for North of the Tyne on Thursday 2nd May and for the European Parliament elections on Thursday 23rd May 2019.
